_____ **Local authors:** Fee waived for Boulder County residents writing **book** about local history if published in Colorado.

_____ **Educational exhibits:** Fee waived for educational exhibits and presentations where no admission charged.

_____ **Historic landmarking/preservation projects:** Fee waived for government led and historic organization led landmarking/preservation projects, or individual representing self in landmarking/preservation project.
